Letter of explanation on the use of open data

The issues of access to information and its use are regulated by the Laws of Ukraine "On Information", "On Access to Public Information", "On State Registration of Legal Entities, Individual Entrepreneurs and Public Formations", "On Access to Court Decisions" and other Laws and by-laws.

Thus, according to the second part of Article 20 of the Law of Ukraine "On Information", any information is open, except for information classified by law as information with limited access.

Article 10-1 of the Law of Ukraine "On Access to Public Information" determines that public information in the form of open data is public information in a format that allows its automated processing by electronic means, free and free of charge access to it, as well as its further use. Public information in the form of open data is permitted for its further use and dissemination. Any person may freely copy, publish, distribute, use, including for commercial purposes, in combination with other information or by including in their own product, public information in the form of open data with a mandatory reference to the source of such information.

The Law also stipulates that the list of data sets to be published in the form of open data, requirements for the format and structure of such data sets, the frequency of their updating are determined by the Cabinet of Ministers of Ukraine.

Thus, in pursuance of the requirements of the Law of Ukraine "On Access to Public Information", Resolution of the Cabinet of Ministers of Ukraine No. 835 of October 21, 2015 approved the Regulation on data sets to be made public in the form of open data (hereinafter referred to as the Regulation), as well as Resolution No. 867 30.11. 2016 approved the Procedure for maintaining the Unified State Open Data Web Portal (hereinafter referred to as the Procedure). At the same time, an integral part of the Unified State Web Portal of Open Data (hereinafter referred to as the portal) is the Competence Center in the field of open data "Action. Open Data".

The above the Regulations and the Procedure establish mechanisms for ensuring access to public information in the form of open data and interaction with users on open data, as well as requirements for the format and structure of data sets to be made public in the form of open data.

Among the list of data sets to be made public in the form of open data given in the Regulations, there are, among other things: the Unified State Register of Court Decisions, the Unified State Register of Legal Entities, Individual Entrepreneurs and Public Formations, the Unified Register of Enterprises for Which Proceedings have been Violated bankruptcy case, Information on the automated system of enforcement proceedings, the Unified Register of Debtors, the Register of Value Added Tax Payers, Information on Business Entities with Tax Debts, the Register of Single Tax Payers, the Register of Non-Profit Institutions and Organizations, etc.

Each of the above open data, including, is regulated by relevant legislation, which details the information contained (published) in the relevant registers, information and more.

So, for example, a list of information about a legal entity, individual entrepreneur or public formation, defined by Article 9 of the Law of Ukraine "On State Registration of Legal Entities, Individual Entrepreneurs and Public Formations", which includes: name, identification code, organizational legal form of the legal entity, the list of its founders and participants, information regarding the ultimate beneficial owner, the location of the legal entity, a type of activity, information about the management bodies and the head of the legal entity, the size of the authorized capital, etc. At the same time, the information contained in the Unified State Register is open and publicly available, in accordance with Article 11 of this Law.

In compliance with the above legislation and acting exclusively in the legal field of regulation of access to public information in the form of open data, "ENERGY LINE INVEST" LLC (hereinafter - the Company), using official open sources, created its own product - platform (website) **energylineinvest.com**, which accumulates and unifies information from open sources provided by current legislation, for its use by all users of this platform, in order to improve the search for relevant public information in the form of open data.

Thus, the website of the Company and the information posted on it meet the requirements of current legislation of Ukraine.
